

2012 Ultimate Speed Challenge

A racing team will consist of a Driver and Crew Chief. The Crew Chief must be an adult and represent the sponsor or owner of the car. The Team Driver must be 16 years through 24 years of age on All-American Soap Box Derby annual race day. The Team Driver must have participated in an annual All-American Soap Box Derby Competition at Derby Downs in Akron, Ohio if their age is less than 18 (minor) on race day. A driver will not be able to compete as an All-American Local (Stock, Super Stock, Master) Champion or Rally (Stock, Super Stock, Master) Champion and the Ultimate Speed division in the same All-American race week. A substitute driver can be named if/when it is determined a registered team driver has qualified for the All-American race in another division (Local or Rally). The substitute driver must meet all the Team Driver requirements.

The All-American Soap Box Derby headquarters will accept applications for the 2012 Ultimate Speed Challenge beginning February 1, 2012 and ending May 15, 2012. All applications must name the Crew Chief and Driver. A \$250 participation fee must accompany the application. Only applications postmarked within the open application period will be selected. The top ten finishing teams that participated in the 2011 Ultimate Speed challenge will be given registration priority if a qualified application is received from the Crew Chief during the open application period. Crew Chiefs will be notified when their application has been accepted for participation in the 2012 Ultimate Speed challenge. The \$250 registration fee will be returned for those applications that are not accepted. A parental waiver form must be signed for minors. All Team members will abide by the rules of eligibility as stated in the current Official Divisional Rules as published in the Official Ultimate Speed Racing Rules Booklet for the All-American Soap Box Derby.

All team members agree:

Any and all expenses incurred in transporting the Ultimate Speed Race Car to and from Akron shall be at their sole expense.

The team will cause the Race Car to arrive at Derby Downs, Akron Ohio as required for pre-race inspections and trial runs.

The team will meet all deadlines and schedules established by International Soap Box Derby, Inc. for the performance of acts and submission of documentation and information relative to race car construction and team performance.

As a precedent to participation in the Ultimate Speed Competition the team understands and agrees that the team driver with the Race Car shall undergo and pass an inspection conducted at Akron, Ohio by representatives chosen in the sole and absolute discretion of the International Soap Box Derby, Inc. Such inspection shall be conducted in accordance with the rules and regulation set forth in the current Official Divisional Rules. It is understood and agreed that the decisions of the representatives conducting the inspection and officiating the race shall be final.

Team Members will hold harmless the International Soap Box Derby, Inc. as well as any Sponsor or Agent of the International Soap Box Derby, Inc. Any team member younger than 18 years old must have a parental/guardian waiver form signed.
